The BOS has collectively resolved to implement this scheme of Instructions, periods per week and number of credits for all 4 years of B.Tech. (IT) Courses from the academic year 2017-18 onwards. The devised scheme of instructions and other items have been given in Annexure-I.

2. After formulation of scheme of Instructions, the BOS has reviewed and devised the syllabus for B.Tech. (IT) Course as per the guide lines of the AICTE and JNTUH, Hyderabad.
3. The BOS Members unanimously approved to use the following Open Source softwares for execution of programmes in the respective laboratories.

- Introduce “Distributed Systems” subject since the IT students need to enhance their knowledge

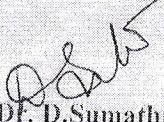
Dr. Suresh Pabboju suggested to
