2. Swap the course FLAT from IV Semester to III Semester and course Probability and Statistics from III Semester to IV Semester.
3. Swap the DBMS theory and lab courses from IV Semester to III Semester and Operating System theory and Lab courses from III Semester to IV Semester.
4. Replace Object oriented Analysis and Design Professional course with some other course such as Object-Oriented Software Design.
5. The BOS members have approved a revised panel for paper setters and Evaluators /examiners for both theory and practical of all the subjects of 4 year B.Tech.(CSE) Courses for the AY 2019-20.

The previous 11th UG CSE Board of studies meeting in AY 2019-20 was held on dt: 1st July 2019. The following are the resolutions made in the meeting and corresponding actions taken are as follows

Resolution 1: Instead of randomly selecting the subjects, the tracks / buckets can be formed regarding the Professional Elective Categories.

Action Taken: Professional Elective Categories are formed based on tracks / buckets and kept for discussion.

Resolution 2: Probability and Statistics & Discrete Mathematics courses should not be in the same semester

Action Taken: Probability and Statistics & Discrete Mathematics courses are proposed in different semesters in forthcoming MR20 Regulations.

Resolution 3: Android Application Development Course may be replaced with AWS, Agile Modeling / Agile Processing, DevOps courses

Action Taken: AWS is proposed to replace Android Application Development Course.

Resolution 4: The VIII Semester courses may be compensated through Credit transfer options by MOOC, so that the students will get more exposure through Internships and Project oriented activities, which enhances employability

Action Taken: Proposing NPTEL/ MOOC courses may be compensated through Credit transfer options in VIII Semester

Resolution 5: Theory and concern laboratories distribution of Credits has to be done evenly throughout the Course.

Action Taken: Kept for discussion.

Resolution 6: Continuity in the Professional Elective Categories should be maintained.

Action Taken: Kept for discussion.

Resolution 7: Based on the necessity, the laboratory courses may be integrated with the Core and Elective Courses.

Action Taken: Proposed in forthcoming MR20 Regulations.

Resolution 8: Activities related to Research, Teaching, Extension and other Academic activities should be elaborated separately in detail.



Resolution 9: Generic / Basic / Superficial subjects are suggested to incorporate in Open Electives



Approved all other schema and syllabus for I and II years of CSE course, syllabus for servicing departments i.e Object oriented Programming lab, Data structures fundamentals lab, DBMS fundamentals lab, and requested to forward the same for 13th BoS meeting to be held in the department for the academic year 2020-21.
