

reviewed and discussed agenda points and finally the following items have been resolved unanimously by all the members of BoS to implement from the academic year 2021-22onwards.

The following resolutions are approved after careful discussion and observations.

1. The BoS Members have thoroughly reviewed and approved the MR20II Year course schema and syllabus of B.Tech. (CSE) Course as per the guide lines of the AICTE, UGC and JNTUH, Hyderabad.

The following are the suggestions made by the members of the BoS and to be incorporated in MR20 regulations CSE schema and syllabus.

- NPTEL courses to be termed as MOOC (with subcategory courses)as Professional Core / ElectiveCourse with credits (equivalent to corresponding course credits in schema) and hence can be claimed under Credit transfer as per the guidelines of AICTE/UGC up to 20% credits.
- Students can register MOOCs course in the preceding semester if all prerequisites of the registering course are satisfied.
- Entrepreneurial Skill Development course can be given one credit and can be allocated from HSC category.
- Guidelines for Internships to be drafted as per AICTE/UGC guidelines and 1 credit to be assigned to Internship I and II courses, 2 credits to be assigned to Internship III.
- Minor Project to be given 2 credits and Major project's credits must be restricted to 8 credits.
- Advised to continue courses like Data Mining as Professional Core course instead of Machine learning course.
- Data structure lab course to be implemented with C.
- Concepts on popular / different types of Operating systems and case studies on Unix, Android and Macintosh OS's to be covered in Operating System Course.

Finally, Dr. R. P. Ram Kumar, Chairman -CSE BoShas expressed his sincere thanks to all the Members of the BoS for their active participation and contribution. The meeting concluded at 04:30 PM.
