1. It was suggested to name the subject as Surveying instead of Surveying and Geomatics since the syllabus mainly covers only surveying. The Geomatics part can be removed and a separate course can be identified as Advanced Surveying including this topic.
2. In BMCP course the board suggested to include advanced materials topics in Module 2.
3. The course Foundation Engineering can be placed in Core and not in Elective, since it has more importance in GATE examination.
4. All the members of the board approved to have only Project in the VIII Semester.

5. The members suggested including one theory subject in VIII semester, if possible in the form of NPTEL or MOOC Course.



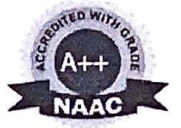
