

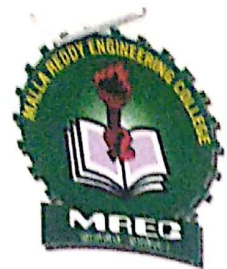

At the outset, Dr. K. Anil Kumar, I/C HOD and Chairman of the MBA - Board of Studies, welcomed the members to the Board of Studies meeting. The Chairman placed on record, the existing syllabus of MR 15 regulations and also proposed modifications for MR17 regulations syllabus (Batches admitted from 2017-18 onwards) as per the agenda.

The Board of studies Members has in detailed discussed, reviewed all the above syllabuses. The following suggestions were made by the members of the Board of studies.

The following resolutions are made after careful discussion and observations.

- The department proposed to have 12 POs for MR17 Regulations and BOS members have approved the same after thorough discussions.
- Introduction of **GST topic in Business law and regulations subject**
- Data collection topic is introduced in **Research Methodology** which may more useful to the students in doing their project work.
- The department proposed a new paper called **Digital Marketing** in place of Marketing Research and it is accepted by BOS members.
- Deleted Investment V/S Gambling topic from **Security analysis and portfolio management** and introduced investor Psychology and investment decisions and renamed the topic **Bond valuation and management as Bond valuation.**
- Regarding web sites, BSE, NSE, amfi.india.com, SEBI are suggested by the Board.
- Dr. Sindhu (University Nominee) suggested to include journals relating to the concerned subject like:
 - a. Journal of portfolio management
 - b. Journal of finance
- Gratuity Act- 1972, provident fund act- 1952, ESI Act-1948, Maternity Benefit Act- 1961 and Payment of Bonus Act- 1965 with all the latest amendments are introduced in **Industrial relations and labour law** subject.
- Suggested to add case studies in **Compensation and reward management** and **Industrial relations and labour law** subject.

- Suggested to reorder the modules in **Engineering Economics and Accounting** subject, should begin with forms of business and the module to be renamed as business environment and managerial economics. Suggested to remove the topics like two part pricing, block pricing, bundle pricing, limit pricing etc and instead of mentioning as skimming and penetration pricing, rename the concept as PLC based pricing methods.
- The university nominee Dr. Sindhu suggested conducting tutorial on Tally, and Accounting Package for making the students better understand the process.
- Suggested to renaming **Management Science** subject as Management Fundamentals, include Planning and to rename the module as Planning and organizing and to include the concept of staffing, operations management as separate module, in lat module suggested to put project management first and. the contemporary management practices later and it is also suggested to include bench marking, balanced score card and the basic concepts of ERP
- Suggested to include Benchmarking, Balanced Score card and ERP by deleting the old and out dated concepts like MRP and MIS in **Industrial Management**.
- Suggested including social ethics in **Human Values and Professional Ethics** subject in making them responsible towards the society as well and topics related to personal, team and organizational ethics.
- Suggested to make five Modules for **Law for Engineers** like all other subjects and it is approved to include latest labour laws, renaming the module Cyber crimes as cyber laws.
- Suggested to keep only Entrepreneurship topics in subject **Entrepreneurship skills** and renaming subject as Entrepreneurship and also suggested to make it five modules like all other subjects and to include financing sources of entrepreneurship in the syllabus.

Finally, Dr. K. Anil Kumar, Chairman - MBA Board of Studies has expressed his sincere thanks to all the Members of the Board of studies for their active participation and contribution. The meeting concluded at 1:30 PM.
