#### (57) Abstract:

The present disclosed invention relates to a hydrogel with enhanced sterilization product 5 comprising a biocompatible polymer and silver nanoparticles, and the hydrogel of the present invention has basic properties for use in wound treatment such as burns, i.e., body fluid absorption, ease of attachment to and detachment from wounds or skin, It has transparency, ease of handling and storability, and in particular, the effect of wound treatment is improved due to the toxin removal effect by silver (Ag) nanoparticles and the excellent sterilization effect 10 on viruses and various bacteria, so it is applied to wound treatment for skin regeneration treatment. It can be usefully used as a dressing.
