LINE OF THE EXECUTIVE BODY AND OFFICE BEARERS

- President: He presides over all the meetings of the both General body and Executive Committee. He can cast his vote in the case of tie.
- 2) Vice-Presidents: He shall assist the president in discharging his functions. In the absence of the President he will perform the duty of the President as entrusted by the President.
  - 3) Secretary: He is the Chief Executive Officer of the Society and custodian of all records relating to the society and correspondent on behalf of the society. He has to take on record all minutes of society to convene both the bodies of the society with the permission of the President. He guides the Treasurer in preparing the budget and expenditure statement to put before the General Body for its approval.
  - 4) Joint Secretary: He has to do the work as entrusted by the Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary he can perform the duties of the Secretary.
  - 5) Treasurer: He is responsible for all the financial transaction relating to the society. He has to maintain accounts properly expenditure statement of the society with the guidance of the secretary. He has to prepare the account of the society jointly with the Secretary or President.
  - 6) Office Bearers: They are the responsible persons to attend to such activities of the society which the Executive Committee entrusts to them.
  - 7) Quorum: Half of the total members for general body meeting and 1/4 for executive body meeting.
  - 8) Funds: The funds shall be spent only to the attainment of the objects of the society and no portion thereof shall be paid or transferred directly or indirectly to any of the members through any means.
  - 9) Amendment: No amendment or alteration shall be made in the purpose of the association unless it is voted by 1/3 of its members present at a special meeting convened for the purpose and confirmed by 2/3 of the members present at second special meeting.
  - 10) Winding up: In case the Society has to be wound up the property and funds of the society that remain of the discharging the liabilities if any shall be transferred or paid to some other institution with similar aims & objects.

- (3) To establish self employment units for unemployed youth on no profit and no loss basis.
- (4) To work for protection of environment, development of greenery etc.
- (5) To protect sovereignty & integrity of nation and promote brotherhood and tolerance among the different sections of the society.
- (6) To encourage study of Indian culture and inoculate sense of discipline, character building, dignity of labour, moral values etc among boys & girls, students etc.
- (7) The funds of society shall be spent for the attainment of aims and objects of society.
